CF Rules changes

The general assembly of the World Curling Federation has approved some changes

of tt so of play and rules of competition. The exact wordings of the new WCF rules will be sent to the national curling associations later this spring for updating their own rule books.

1] The width of the ice sheet may be reduced from 4,75m (15ft 7 inches) to 4,42m (14 ft 6 inches).

2] Substitute of a team coming in during a game will be permitted to play at any position and the rotation of play may be changed at the discretion of the skip or coach who shall inform the Chief Umpire of the new rotation.

3] Sweeping behind the teeline. Any one player of the delivering team may continue to sweep their stone or the opponent's stone

behind the tee line

4] Time-out at World Championships. Each team may call two 60 second time-outs per game excluding extra ends and one 21 second time-out during an extra end. 5] The game time will be reduced to 73 minutes per team.

6] The minimum age limit for participating in a World Curling Championship, currently 16, is being removed.
